## **Becoming Social**



This project is now complete and a project outcomes launch was held on 24 July 2014 at Customs House, Sydney. The launch provided an opportunity for participants to learn all about social media - connect with colleagues, demystify what platforms to use, increase confidence creating campaigns and get the project resources.

The Becoming Social project was designed to increase Councils' understanding and use of social media as a relationship and policy development tool to engage, consult and educate coastal communities in relation to local and regional coastal environmental issues.

Key project outcomes are:

- The Becoming Social web-based tool which assists users to make decisions about what social media platform to use based upon a project's key elements
- The Becoming Social online community platform where Member Councils can come together and discuss their needs, requirements or campaigns, and receive feedback from other representatives in the community
- The additional social media resources developed for councils available through the tool, such as monitoring a social media project
- The social media survey
- The social media literature review.

## Emergency Risk Management (continued)

The Health Check is a tool for Councils to self-assess their preparedness and capability for emergency management. The tool supports an integrated approach to emergency management across many functional areas as it builds on councils' roles in strategic planning, risk management, asset management, business continuity planning and WHS.

We consulted with 30 Councils across the State to trial and develop the Health Check. The feedback informed a revised format to improve engagement, ease of use, and reporting of outcomes. The Health Check is not an audit of what a council must do in emergency management, but an opportunity for council staff to explore options and priorities to develop a program relevant to their own circumstances and community needs. The SCCG welcomes the interest of councils in using the tool and all materials will be freely available.

## Sydney Harbour Coastal Zone Management Plan (CZMP) Scoping Study

The Literature Review and draft Scoping Study are progressing. A key deliverable for the project consultant is to investigate, evaluate and synthesise literature and data related to management and use of the Harbour. The Project Advisory Committee and a stakeholder survey assisted to populate the literature evaluated. The consultant has completed a draft of the Literature Review, which was sent to the Advisory Committee for

review and comment. The consultant is now addressing those comments and the final Literature Review will be available shortly.

## Sydney's Salty Communities - Turning the Tide on Blue+Green Carbon

We have issued a Request for Quotations for a Coastal Biodiversity Literature, Data and Practice Review. We are also finalising recruitment for an officer to manage Stage 2 of the project. Meanwhile, the project's independent Reference Group is being formed. This group of eminent individuals will provide specialist technical input, guide and/or undertake research, review prioritisation and evaluate sub-projects under the devolved grants program. Members of the Reference Group have expertise in Sydney's coastal ecosystems, ecological restoration, urban biodiversity and organisational capacity-building and will provide help to achieve project outcomes.

We are also developing the process for assessing project proposals for Salty devolved grants. Funding will be

available to fill research and policy gaps, provide key resources and to primarily undertake on-ground planting, weed control and rehabilitation of remnant coastal vegetation communities and key habitats across Sydney. Visit the project web page for more information: http://bit.ly/ZqiGqK

Our Executive Officer, Geoff Withycombe, provided an overview of the Group's activities and achievements during 2013-14. Highlights included:

- securing \$1.9M in successful grant applications
- facilitating 96 internal meetings and attending 94 external meetings
- facilitating 4 major forums and hosting 6 key events with partners
- receiving the 'Highly Commended' Award at the 2013 NSW Coastal Management Awards for our seawalls project and the 'Highly Commended' Award at the 2013 Resilient Australia Awards for our Landslide Risk Management website.

## SCCG 25 Year Anniversary

This year, we celebrate 25 Years of Caring for our Coast. Since our establishment in 1989, when we partnered with the EPA and the Water Board (now Sydney Water) to end shoreline sewage outfalls off Sydney's iconic beaches, we have grown to become a recognised leader in sustainable coastal and estuarine management. Now with 15 Member Councils, the Group represents over 1.4 million Sydneysiders.

On 29 August 2014, we hosted a Conference and Gala Evening to celebrate our Anniversary. The two events provided a unique opportunity to reflect upon the coast, unite Member Councils and key partners, both past and present, and promote engagement, dialogue, and visioning regarding future stewardship.

#### **Commonwealth Marine Reserves Review**

The Commonwealth Government has set aside a suite of management plans for Australia's marine reserves. The plans were due to come into effect in July 2014, but will be replaced by a new set of plans following a Marine Reserves Review recently commenced. The Government states it is delivering on its election commitment for a 'More Competitive and Sustainable Fisheries Sector'.

#### Climate Council report on coastal flooding risk



The Climate Council has released a report on climate change and coastal flooding. The report finds that Australia is highly vulnerable to increasing coastal flooding due to extensive development along the coast. Climate change will exacerbate coastal flooding and put many natural and built assets at risk.

The authors calculate that \$2.26 billion worth of infrastructure and homes would be at risk under a scenario of 1.1m sea level rise. They call for urgent cuts in greenhouse gas emissions this decade and beyond to avoid the most serious risks from rising sea levels and coastal flooding. #### New laws on clearing in bushfire prone areas under review

Less than 2 months after its introduction, the NSW Rural Fire Service (RFS) has announced changes and a review into the *10/50 Vegetation Clearing Code of Practice*. The Code of Practice allows people who live in designated '10/50 vegetation clearing entitlement areas' to clear trees on their property within 10 metres of a home and underlying vegetation (such as shrubs) within 50 metres of a home without seeking approval. Since the introduction of the Code on 1 August 2014, there have been significant concerns raised by a number of councils and community groups, relating to threatened species and ecological communities, inadequate consultation, lack of distinction between urban and bush land areas, and monitoring and compliance issues. In light of these concerns, at its AGM on 13 September



2014, the SCCG Full Group Committee resolved to write to the NSW Government seeking an immediate suspension of the Code and an urgent and independent review. Since then, the RFS has announced changes to the Code and a review. Submissions can be made by email to 10.50@rfs.nsw.gov.au until 14 November 2014.

The NSW Parliamentary Research Service has prepared an e-brief which explains the current NSW regulatory regime, summarises the new changes and canvasses some stakeholder responses to the proposed reforms. ## Stage 2 Coastal Reforms

The NSW Government is looking to strengthen support for councils' coastal management through the stage 2 reforms. The Office of Environment and Heritage (OEH) would like to work with councils to develop improved guidance material to better support council decision making. It is envisaged that the improved guidance will consolidate existing coastal guidance and fill information gaps that currently exist. It will build on good practice already adopted by many councils. The guidance will provide government direction to support council coastal management decision-making.

Staff from OEH working on the reforms met with SCCG and Sydney Councils on 10 September to discuss the best way to work together to develop new coastal management guidance. The meeting was very productive and generated many useful ideas about how OEH could better support councils. OEH plans to hold workshops to define and scope the new guidance with councils and other NSW Government agency staff in November and December.

## Seawall at Old Bar rejected

The NSW Government has agreed to certify the Greater Taree Coastal Zone Management Plan prepared by council, subject to minor amendments, but has not supported construction of a seawall at Old Bar. The seawall was estimated to cost \$50 million with a lifespan of 50 years. The NSW Environment Minister, the Hon Rob Stokes MP, noted that "the option to construct any protection structure at Old Bar is likely to transfer the problem to future generations to deal with, which is unacceptable." Greater Taree City Council will now work with OEH to consider options to relocate development that is exposed to coastal erosion.

## 'Fit for the Future' - reforming Local Government

The NSW Government has announced reforms to Local Government. The *Fit for the Future* package is based on the Independent Local Government Review Panel's recommendations following three years of research and consultation. According to the Government, the package includes:

- \$258 million to assist councils who decide to merge and make the changes needed to provide better services to communities
- cheaper finance for councils to build and maintain necessary community facilities, saving them up to \$600 million
- up to \$100 million savings through reduced red tape and duplication
- improvements to the local government system,
- including the laws that govern it, the way the State works with councils and the support that councils receive.

  Fit for the Future

Councils will have until 30 June 2015 to submit proposals on how

they plan to be 'Fit for the Future'. These will be assessed by independent experts against independently-set criteria. More information is available at: <u>www.fitforthefuture.nsw.gov.au</u>

## Draft Regional Boating Plans under development

The Maritime Management Centre (MMC) and Roads and Maritime Services (RMS) are undertaking a statewide study of existing boating facilities and safety measures to inform the development of Regional Boating Plans for each of the major waterways in NSW. The study will identify actions required to enhance the boating experience across NSW by improving boating safety, boat storage and waterway access on major waterways.

#### **Biodiversity Legislation Review**

The State Government is currently reviewing Biodiversity legislation in NSW. An independent panel has been appointed to consider the policy settings, programs and funding arrangements that support the management of biodiversity, threatened species and native



vegetation in the State. The review aims to establish simpler, streamlined and more effective legislation that will:

- facilitate the conservation of biological diversity
- support sustainable development
- reduce red-tape.
